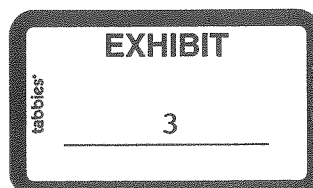

**DECLARATION OF DONALD SPENCER**

I, Donald Spencer, declare as follows:

1. I am an adult individual and reside at 3795 West Porcupine Lane, Dunellon, FL 34433.
2. I have created an account in Second Life, which is operated by Linden Research, Inc. ("Linden").
3. I read written statements and representations made by Defendants in the media regarding the ownership of virtual property in Second Life.
4. I believed the statements made by Defendants that the virtual items and land I purchased and created in Second Life meant that I owned them.
5. I purchased and created virtual property in Second Life and had my U.S. currency converted to "lindens."



6. I lost a significant amount of money when Defendant Linden improperly confiscated my virtual property and items and money.

7. I believe that Defendant Linden improperly confiscated virtual property and items and money around the same time as Marc Bragg.

8. I have not activated that account again and, as such, I believe it remains subject to the Terms of Service that include the unconscionable arbitration provision.
